

Dribbble's Hang Time Seattle Playoff 2018 CONTEST OFFICIAL RULES (The "Rules")

THIS IS A SKILL-BASED CONTEST. VOID WHERE PROHIBITED.

Important: Please read these Rules before entering this Contest. By participating in the Contest, you agree to be bound by these Rules.

- 1. This Contest (The "Contest) is sponsored and administered by Dribbble Holdings Ltd. (or "Sponsor"), having its principal office at 101-524 Yates Street, Victoria BC, V8W1K8.
- 2. ELIGIBILITY The Contest is open only to persons ("Participant/s") who: (i) are legal residents and are physically located and reside in a jurisdiction in which this type of contest is permitted; and (ii) are at least eighteen (18) years of age, or have reached the age of majority in his or her jurisdiction of residence at the time of entry, whichever is greater. Employees of Sponsor and their respective parent, affiliates, subsidiaries, advertising and promotion agencies, distributors and other prize suppliers, directors, officers, and each of their immediate family members and/or those living in the same household of each are not eligible to enter the Contest. This Contest is void where prohibited by law.
- 3. ENTRY PERIOD Entries can be submitted from April 4th to April 13th (the "Entry Period")

## 4. HOW TO ENTER

- 4.1. The Contest will determine which Participant has the best combination of creativity and originality during the Entry Period, all subject to the judgment criteria specified in Section 5 below. To enter the Contest, you must post your unique design conceptualization of "Quality over Quantity" on the contest page on Dribbble available at <a href="https://dribbble.com/shots/4427319-Seattle-Playoff">https://dribbble.com/shots/4427319-Seattle-Playoff</a> (the "Contest Page")
- 4.2. Upon successfully posting your unique design (as described above) on the Contest Page in accordance with these Rules, you shall be considered to have submitted an entry to the Contest ("Entry" or "Entries"). An Entry is "received" when the Entry is published on the Contest Page according to these rules and remains accessible by Dribbble at least throughout five (5) business days following the end of the Entry Period. Proof of submitting an Entry will not be deemed proof of receipt by Sponsor. The odds of winning depend on the number and quality of the Entries received.



- 4.3. For the avoidance of doubt, Participants may enter the Contest via Dribbble only. You must have an open or public Dribbble account to participate.
- 4.4. For the avoidance of doubt, Participants may enter the Contest via Dribbble only. You must have an open or public Dribbble account to participate.
- 4.5. Sponsor has no obligation to advise you of an incomplete or otherwise non-compliant Entry. You are solely responsible for internet connectivity, software and/or hardware that may be required in order to create and/or submit your Entry. Dribbble and its agencies assume no responsibility for lost, interrupted or unavailable network, server or other connections; miscommunications; failed phone or computer hardware or software or telephone transmissions or technical failures; ISP/network/website accessibility or availability; garbled or jumbled transmissions; injury or damage to any participant's or to any other person's computer related to or resulting from participating in this Contest or downloading materials from or use of the website; and/or other errors of any kind, whether human, mechanical or electronic, including, without limitation, the incorrect or inaccurate capture of online entry information.
- 4.6. Entries generated by a script, macro or other automated means will be disqualified. Entrants must provide all information requested to be eligible to win. Eligible entrants must submit their entry in accordance with these Official Rules. No alternate form of entry will be accepted. Dribbble's decision not to enforce a specific provision of these Official Rules does not constitute a waiver of that provision or of the Official Rules generally.
- 5. PRIZES The prize for first place is one (1) ticket to Dribbble's Hang Time Seattle Conference on May 15th, 2018. There will be three (3) honorable mentions. Honorable mentions winners will receive a free year of Pro and some special Dribbble swag, to be chosen at Dribbble's discretion and duly communicated. No alternative prize, cash equivalent, or other substitution is permitted except by Dribbble in the event of prize unavailability. All federal, state and/or local taxes are the sole responsibility of the Winners. Any change in prizes will be duly communicated to parties involved. Prizes will be awarded provided a sufficient number of entries are received. Taxes (if any) and other expenses not specified herein are Winner's responsibility. This includes but is not limited to expenses or transportation other than that directly stated, transfers or changes made by the winner. This Contest is subject to all federal, state and local laws.

- 6. TO CLAIM PRIZE Potential winners' claims to prizes are subject to verification by Dribbble. Failure of a Potential Winner to return correspondence within 72 hours of initial contact from Dribbble will result in forfeiture of his/her prize and selection of an alternate Winner from the remaining eligible entries by the same judging criteria as the original winner selections. If any prize correspondence (including e-mail) is returned as non-deliverable, an alternate winner might also be selected by the same judging criteria as the original winner selections. The course of action in this scenario will be in the sole discretion of Dribbble and duly communicated to parties involved.
  - 6.1. Entries will be deemed to be made by the person whose Dribbble account is used for the posting of the Entry. In the event of a dispute relating to ownership of a winning Entry, Sponsor may require a potential winner to provide proof that they are the authorized holder of the identified account. Sponsor shall be entitled to use its best judgment, in its sole discretion, to determine the rightful owner of the winning Entry, and each Participant hereby remises, releases and discharges the Sponsor, to the fullest extent permitted by law, from all liabilities, obligations, claims, and demands whatsoever arising out of any such determination of the rightful owner of the winning Entry by Sponsor. Sponsor may run multiple campaigns, contests, sweepstakes or other promotions simultaneously and Sponsor is not responsible for Entries incorrectly posted on Dribbble or elsewhere. Entry into one (1) promotion does not constitute entry into any other.
- 7. RELEASE By entering and/or participating in the Contest, winners and participants agree to indemnify and hold Dribbble and its affiliates, subsidiaries, advertising and promotion agencies and the agents and employees of each harmless from any and all liability, damages or causes of action (however named or described) with respect to or arising out of the Contest and the use of bonus awarded. Entering and/or participating in the Contest constitutes permission to use winner's name and/or likeness and address for the purpose of advertising, publicity and promotion without further compensation except where prohibited by law.
- 8. RIGHT TO DISQUALIFY: Dribbble reserves the right, in its sole discretion, to disqualify any individual found, in Dribbble's sole discretion, to be tampering with the entry process or the operation of the Contest, or website, or to be acting in violation of the Official Rules; to be acting in violation of the terms of use of the website, or to be acting in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person. This includes any design posted on Dribbble for whatever reason that does not comply with our Terms & Conditions. Participants may not enter using multiple e-mail addresses or as multiple identities. Any entrant who attempts to



enter with multiple e-mail addresses or under multiple identities, or uses any other device to enter multiple times will be disqualified. Dribbble reserves the right to suspend or terminate this Contest without notice if, in Dribbble's sole discretion, the Contest becomes infected or otherwise corrupted; in such event, Dribbble will select winners from all eligible entries received prior to and/or after (as appropriate) the action taken by Dribbble. Any attempt by an entrant to deliberately damage or undermine the legitimate operation of the Contest is in violation of criminal and civil laws and should such an attempt be made, Dribbble reserved the right to seek remedies and damages from any such entrant to the fullest extent permitted by law, including criminal prosecution. The failure of Dribbble to comply with any provision of these Official Rules due to an act of God, act of domestic terrorism, hurricane, war, fire, riot, earthquake, terrorism, act of public enemies, actions of governmental authorities outside of the control of either (accepting compliance with applicable codes and regulations) or other force majeure event will not be considered a breach of these Official Rules.

- 9. INFORMATION COLLECTED AND TERMS: Participants acknowledge and agree that any information collected in connection with this Contest may be used by Dribbble for market research, and will not be shared with other organizations for commercial and other purposes. Any information submitted to Dribbble in connection with the Contest is subject to Dribbble's <a href="Privacy Policy">Privacy Policy</a>, and Dribbble's <a href="Terms & Conditions">Terms & Conditions</a>.
  - 9.1. Participation in the Contest constitutes Entrant's understanding of and full and unconditional agreement to and acceptance of these Official Rules. Dribbble reserves the right to disqualify any Entrant that they determine to be in violation of any term contained in these Official Rules.
  - 9.2. Dribbble has sole discretion for how to resolve any Contest-related issue that is not mentioned within these Official Rules. Any course of action for an issue falling under this clause will be duly communicated to those involved.
